Iraq Certificate of Conformity (Coc) Services

Businesses trading with regulated products in Iraq must demonstrate their compliance in the exporting country before entering the Iraqi market.

The Iraqi Central Organization for Standardization and Quality Control requires a Certificate of Conformity (CoC) for multiple categories of goods imported into Iraq. The goal of the conformity program is to limit non-compliance, as well as the import of counterfeit or defective products into













the country, thereby protecting domestic consumers, producers, and the environment. It is important for importers and exporters to comply with these regulations, as failure to comply can result in delays, penalties, or the shipment being returned.



Regulated Product Categories

An official Iraq CoC issued by an authorized third party is required for exporting 12 product categories and more than 700 individual products into Iraq.

These categories include:

-  • Food
-  • Electronics
-  • Footwear and Textiles
-  • Automobiles
-  • Tires and Auto Parts
-  • Construction Materials
-  • Chemicals
-  • Soaps and Detergents
-  • Hardware Tools
-  • Household Items
-  • Toys
-  • Kitchenware
