




Uganda Pre-Export Verification of Conformity

Businesses trading with regulated products in Uganda must demonstrate their compliance in the exporting country before entering the Ugandan market.

The Uganda Pre-Export Verification of Conformity (PVoC) is an inspection and verification program operated by the UNBS. The program came into force in June 2013 and aimed to protect the Ugandan market against substandard products and ensure that imported goods are safe for consumers.

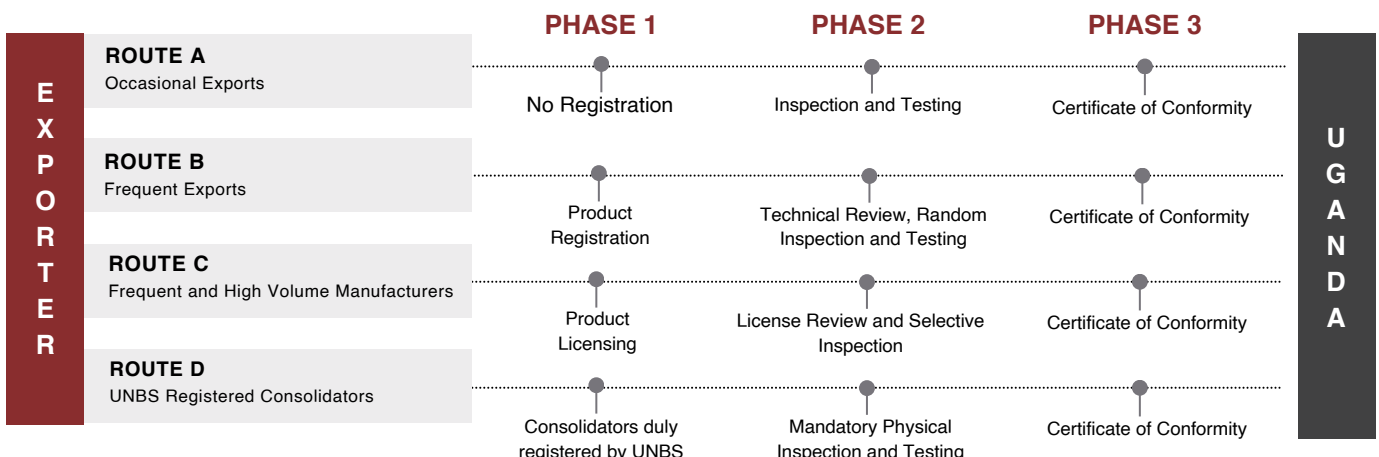
The program covers 11 product categories and requires that every regulated product must have a Certificate of Conformity (CoC) certification issued by appointed inspection agents in the country of export. Failure to comply with these regulations can result in delays, penalties, or the shipment being returned.

Regulated Product Categories

-  • Toys
-  • Textile, Leather, Plastic and Rubber
-  • Electrical and Electronics
-  • Furniture
-  • Automotive Products and Inputs
-  • Paper and Stationery
-  • Chemical Commodities
-  • Protective Safety Equipment
-  • Mechanical/Construction Materials and Gas Appliances
-  • Food and Food Products
-  • Used Commodities including Used Motor Vehicles

Routes For PVoC Inspection

The process of certification will vary depending on the product category and the type of exports. There are four different certification routes.



Fee Structure

Routes	FOB Value	Minimum / Maximum Fees
A	0.5%	USD 235 / USD 3,000
B	0.45%	USD 235 / USD 3,000
C	0.25%	USD 235 / USD 3,000
D	0.5%	USD 235 / USD 3,000

- *Commodities are exempt from PVoC when the Freight on Board (FOB) value does not exceed USD200.*
- *The above-stated fees cover only the document review, inspection activities and issuance of a Certificate of Conformity. Contact our customer service to get an estimated price quote for your shipment.*
